# The Promise and the Practice of Our Faith Racial Justice, adapted from 2017 Service by Rev. Erika Hewitt

It was 102 Sundays ago in the Before Times that we turned on a dime with COVID breathing down our necks to move the life of this Beloved Community into a virtual world we knew little about, but knew we must venture into to keep safe and stay connected at the same. The "we" was so many people with the skills, courage, commitment, and love who rose to challenge. The Sunday worship we knew and loved "then" was all of us in a room in a building at the same time every Sunday. Then, as COVID took over our known world, we did 89 Sundays in a row fully virtually, for despite our plan to begin a new way with First Sundays Blended Worship (in-person + virtual), plus Three Virtual, COVID challenges prevented us being together safely until December, and keep us virtual even now

as the Omicron variant winds down (Broward's COVID stats are better, but still outside our COVID policy for large gatherings).

#### Let's talk football...

It seems fitting as Super Bowl LVI is this Sunday, Feb 13<sup>th</sup>. African Americans make up 68% of the players in the NFL, but only two are NFL head coaches.

Brian Flores, an African American football coach in the National Football League, began his NFL career with the New England Patriots, where he served as an assistant coach from 2008 to 2018. He was fired by the Dolphins last month after two winning seasons and then replaced with a bi-racial coordinator from the 49ers. Flores has had some condescending interviews with other teams but none offered employment. He is suing the Giants due to the tip-off of an accidental text message indicating the interviewing team had already offered the job to a white candidate and Flores' interview was just for show.

"It's hard to speak out," Flores said on CBS, "But," he added, "this is bigger than football. This is bigger than coaching."

Robert Griffin III, a former quarterback, tweeted: "Brian Flores effectively had to end his chances at coaching in the NFL to point out what we already know about discrimination in the hiring process for head coaches in this League."

Finding ironclad proof of racial discrimination is rarely easy, especially in an individual case. But the evidence that the NFL has engaged in a pattern of discrimination against Black coaches is very strong when you consider the number of black players on all football teams. Just something to ponder as you watch the game...

#### Heritage and Hope:

**Heritage – Henry Bergh** (1811-1888) was the founder of the American Society for the Prevention of Animal Cruelty, having dedicated his life to the cause of ending animal cruelty.

Under Bergh's leadership, the early ASPCA involved itself in a wide variety of issues, including slaughterhouse practices, animal transportation, care of horses, elimination of vivisection, cock fighting, and dog fighting, and the abolition of use of live pigeons in shooting matches. Bergh and the ASPCA are particularly credited for the use of clay pigeons in trap shooting.



During the 1872 outbreak of Horse Flu, Bergh stood wearing a top hat in the middle of New York City's streets and stopped horse-drawn trolleys and wagons being pulled by sick animals, sending them back to their stables. Although he was threatened with lawsuits by transit companies, his advocacy raised the profile of the cause.

Bergh commenced his life work not from an affinity with animals, nor as a squeamish sentimentalist, but stirred by suffering and injustice. Some newspapers labeled Bergh "the Great Meddler"; others, "An Ass That Should Have His Ears Cropped."

Bergh's industriousness knew few bounds. He developed slings for injured horses and clay pigeons for shooting matches. Uninvited, he waded into legislatures in white spats and slaughterhouses in rubber boots. Criticized for tending animals rather than people, he replied that if animals had to await mercy until human affairs were resolved, they would still be waiting at the Second Coming.

Poet Henry Wadsworth Longfellow eulogized Bergh as "among the noblest in the land, Though he may count himself the least, that man I honor and revere, who without favor, without fear, in the great city dares to stand the friend to every friendless beast."

"This is a matter purely of conscience. . . "It has no perplexing side issues. . . . It is a moral question in all its aspects." Bergh

UUAM is a group of concerned Unitarian Universalists who express their faith, in part, through compassion towards all beings. They do good work not just for non-human animals, but for people and all of life, knowing that our connection with the more-than-human world helps us live most fully, deeply, and authentically.

The Rev. John Gibb Millspaugh is the Executive Director of the Unitarian Universalist

Animal Ministry (UUAM). His award-winning justice work has focused on modern slavery, LGBTQ rights, climate justice, and animal protection. He led the team that organized over 400 congregations to collectively write and adopt Unitarian Universalism's intersectional "Ethical Eating" statement in 2011, the first known instance of a U.S. faith adopting a position statement of its kind. He and his wife and son live with their dog – who may or may not be a black Labrador mix – in San Diego, CA.



#### Interim Recommendations from the RoG COVID-19 Re-Emergence Team

**Purpose of Team:** To review guidelines for congregational and smaller group gatherings in order to provide recommendations to the Board to be used for official River of Grass meetings and events.

#### These recommendations are:

For: only for official, River of Grass - sponsored outdoor and indoor small group gatherings.

Fluid: new information comes out all the time and the recommendations could change.

Inclusive: all attendees should be able to attend physically or virtually.

Protective: considers first those who are most at risk.

Science-based: follow the directives according to the experts.

#### MEETINGS IN THE TIME OF COVID

#### RIVER OF GRASS COVID-19 TEAM RECOMMENDATIONS TO THE BOARD: updated November 4, 2021

This is a living document that will be regularly reviewed and updated.

River of Grass COVID-19 Re-Emergence Team is monitoring Broward County's risk level of transmission. The level of risk used by the River of Grass UU Congregation shall be as measured on <u>Broward County</u>, <u>Florida (FL) - COVID Vaccine & Risk Tracker - Covid Act Now</u>. Risk levels are <u>low</u>, <u>medium</u>, <u>high</u>, <u>very high</u>, and <u>severe</u>.

In-person/hybrid Worship services, large group concerts, fundraisers, other large events (with 50 or more participants) shall occur while the COVID risk is at low, medium, or high levels. According to the Updated Gathering Guidance from UUA.org, "In areas where transmission risk is very high or severe, <u>suspend</u> all large in-person (indoor and outdoor) gatherings such as worship, concerts, or fundraisers." As such, in-person worship services and other large gatherings shall be suspended if the level of risk for Broward County is and has been very high or severe for two or more weeks. The level of risk, as reported on the COVID Act Now website, will be monitored by

the Re-Emergence Team, which will alert the Board and Worship Team if the risk level changes to or from very high or severe and stays at that level for two weeks.

Further, all attendees of in-person gatherings, small or large, are strongly encouraged to be vaccinated as possible based on eligibility by age. Vaccination or recent negative COVID test is strongly encouraged for in-person gatherings. Facial coverings/masks are required for large indoor in-person gatherings and strongly encouraged for other groups to protect the most vulnerable, including unvaccinated babies and young children. Small groups are encouraged to set-up and enter into their own covenants, using the guidance herein, regarding COVID-19 safety procedures.

If protocols at rental facilities are more restrictive, their guidelines will be followed.
